Sub.- Insurance Policy for Group Mediclaim for Ex-Employees and their spouse of FSNL for a period of 1 (One) Year.

Dear Sirs,

We are interested to take Group Mediclaim Insurance Coverage for our Ex-employees and their spouse valid for a period of 1 (one) year from **20-02-2024** as per **Annexure** attached for **1162 members**.

The benefits under the Mediclaim Insurance Coverage Policy are for Hospitalization Benefits upto **Rs. 4.00 Lakhs per annum with clubbing/ floating facility (as detailed below)** and domiciliary benefits up to Rs. 50,000/- per annum.

The Group Mediclaim Insurance Coverage required on following terms :-

1.	For IPD (Hospitalization) Benefits :-
(i).	Sum Insured per Member will be Rs. 4 Lakhs with clubbing (floating facility) under hospitalization with his/her spouse which means that hospitalization benefits of Rs. 4 Lakhs per members can be clubbed between Mediclaim Members & their spouses (Maximum clubbed) limit Rs. 8 Lakhs per policy period.
(ii).	For those Members without his/her spouse, the Sum Insured per Member will be Rs. 4 without clubbing (floating).



2.	Room rent payable limit @ 1% of SI, ICU charges payable limit @2% of SI without any sub limit or without any propionate deduction.
3.	Waiting period 30 day/ 1 year/ 2 year/ 4 year should be waived. Pre-existing diseases are to be covered from day one in the policy.
4.	Domiciliary Hospitalization Treatment Covered- Rs. 50,000.00 per annum per member.
5.	Pre-existing diseases are to be covered in the policy.
6.	All members should be covered right from day one on inclusion in the policy.
7.	Provision for addition and deletion of members for which premiums should be on prorated basis.

The premium quoted by the successful tenderer should cover all above risk. Specific confirmation to the risks covered and coverage should be mentioned separately in their offer otherwise offer shall be liable for rejection.

Keeping in view, the above parameters, tenderer are requested to quote their premium rates separately showing each discounts and also P.S.U. discount so as to reach on or before **19-01-2024 by 2.30 P.M.**
